## PREAMBLE:

In terms of Section 14(1) of the NCTE Act,1993 Mahendhira College of Education, Kalippatti P.O. Tiruchengodu Taluk, Namkakal District - 637501 Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for Secondary (B.Ed) course on 24.12.2005.

SRC-NCTE caused inspection of the institution on 04.68.2005. Upon consideration of visiting team report and other documents furnished by the institution, the SRC in its 100th meeting held on 23-24 september, 2005 decided to accord recognition. for B.Ed programme with an intake of 100 from the session 2006-07 as the Endorsement submitted by the institution was dated 30.06.2005 and hence belated for being considered for the current academic year 2005-2006 in view of Appendix I-B of NCTE Regulations. 2002. Accordingly a recognition order issued to the institution vide its order No F.TN/SRO/NCTE/2005-06/3369 dated 07.10.2005.

However, in the meanwhile some institutions who have been granted recognition for the subsequent year based on belated endorsements preferred an appeal to NCTE Hqrs, and contended that a few institutions which have submitted belated endorsements were grated recognition for the current academic year. SRC, in its comments to the NCTE flors, explained that this has occurred due to oversight and would modify such orders which have been wrongly issued. Pursuant to this, the National Council for Teacher Education, New Delhi, vide its order No.F.No.89-156/2005-Appeal dated 28th September, 2005 remanded back the cases to the SRC, Bangalore with a direction to reconsider the cases immediately for granting recognition from 2005-2006 on par with other similar cases who have been grated recognition for 2005-2006.

The same has been placed before SRC in its 103<sup>rs</sup> meeting held on 27<sup>th</sup> and 28<sup>th</sup> October, 2005 and SRC after obtaining a considered legal opinion in this regard, has taken a decision to review its recognition orders issued for the session 2006-07 and to grant recognition for the session 2005-06 to those institutions who have submitted belated NOCs/Endorsements as one time exception. This exception is applicable only to the institutions which have submitted belated NOC/endorsement and not to those institutions which have submitted other essential documents mentioned in Appendix 1B, belatedly. Pursuant to this decision of SRC, the institution submitted a written request to the SRC for revising as earlier decision to gram recognition for the year 2006-2007 and to grant recognition for the current academic year 2005-06.

#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution, Mahendhira College of Education, Kalipatti P.O, Tiruchengodu Taluk, Namakkal District 637501, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities
- 3. AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,
  - I. The institution shall submit all the documents and FDRs of the existing course including recognition order issued earlier and the latest affiliation order by 15.10.2015.
  - II. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - III. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
  - IV. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017
- **4. NOW THEREFORE**, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition **Mahendhira College of Education**, **Kalipatti P.O**, **Tiruchengodu Taluk**, **Namakkal District 637501**, **Tamilnadu** for conducting **B.Ed** programme of **two** years duration with an annual intake of **100** students each for two basic units from the academic session **2015-16** subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- 5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant,

- 7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
  - a. Sanctioned programmes along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left or joined during the last, quarter:
  - Names of Students admitted during the current session—along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.
  - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act



Ref: Order of the Vice Chancellor dated 25.10.2018.

I am, by direction, to inform you that the request of Mahendhira College of Education, Namakkal District together with the report of the Inspection Commission, compliance report submitted by the college has been considered and orders have been accorded to grant continuation of provisional affiliation to Mahendhira College of Education to offer B.Ed degree course for three academic years vide reference cited.

In pursuance of the above orders, continuation of provisional affiliation is granted to Mahendhira College of Education, Namakkal District to offer B.Ed degree courses for the academic years 2018-2019 to 2020-2021.

Further the Management shall remit a sum of Rs.1,00,000/- (Rupees One Lakh only) towards a fee for grant of Continuation of Provisional Affiliation for the academic years 2018-2019 to 2020-2021.

The affiliation fee should be paid in the form of Demand Draft drawn in favour of the Registrar, Tamil Nadu Teachers Education University, and payable at Chennai through any Nationalized Bank

The Continuation of Provisional Affiliation is granted subject to the condition that the Qualification approval of Principal, Three Assistant Professors in Perspectives in Educations and One Assistant Professor in Performing Arts should be obtained within a period of 3 months.

The conditions laid down by this University for affiliation are furnished below which the College should strictly adhere to and any lapse will attract penal action under the provision of the Tamil Nadu Teachers Education University Act.

### The Following Conditions shall be strictly adhered to.

- 1. All the conditions laid down by the NCTE, Bangalore.
- Candidates to be admitted in B.Ed. Degree course shall (a) satisfy the eligibility conditions prescribed in the Regulations and the guidelines issued by the Government of Tamil Nadu for the academic year 2018-2019 (b) obtain approval from the University for the students admitted to B.Ed. degree course

- ii. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;iii. Names of faculty members who left or joined during the last, quarter;
- Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission etc;
- v. Fee charged from students;
- vi. Available infrastructural facilities;
- vii. Facilities added during the last quarter;
- viii. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - ix. The institution shall be free to post additional relevant information, if it so desires.
  - x. Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.

While communicating the above decision, I am to request you to kindly forward a specific and detailed report in this regard, immediately after fulfilling all the above conditions of affiliation.

The Management has to apply for Continuation of Provisional Affiliation for the three academic years 2021-2022 to 2023-2024 for which the Management shall submit the prescribed application on or before 31.10.2020 along with the registration fee and processing fee as prescribed by the University.

The receipt of this order shall be acknowledged.
